

Judy Landeck introduced our guest speaker, Kathy Rhodes. Kathy is the president of The Tuscola Community Foundation. The purpose of her program was to educate members about the foundation's structure, activities and grants.

The foundation administers gifts, bequests and donations for agencies, corporations and other tax exempt sources for the

benefit of the residents of the community. It was established in 1994 as a publicly supported non-profit corporation. Programs and services are funded from both its unrestricted (general fund) and its restricted funds. The ten members of the Board of Directors are made up of representatives of the community: Agricultural, Education, Financial, Industrial, Legal, Municipal, Religious and three at-large members. Terms for directors are limited to two consecutive 3-year terms.

Recent grants include \$1,000 to the North Ward library, \$9,900 to the Douglas County Health Department for senior services, \$1,500 to the North Ward breakfast program, \$13,500 for the Mid-Illinois Senior Services Agency and \$1,143.57 for the Nunn Scout Building. The foundation awards several scholarships to graduating TCHS seniors each year. Highlights of July 2009 Board Meeting Minutes

The meeting was called to order on Wednesday, July 1st by President Janet Butler, with the following members present: David Butler, Janet Butler, Janet Cox, Candy Hudson, Don Miller, Kevin Nolan, Dan Russell, Wayne Ward and Gary Weber.

The following items of business were discussed:

- 1. <u>Minutes of June 2009 Board Meeting</u> A motion was made and seconded to approve the minutes as edited. Minutes approved.
- 2. <u>June 2009 Monthly Report</u> There were 21 members participating in the Relay for Life. There were 74 hours of service rendered and a contribution of nearly \$1,500.00 was raised by the Kiwanis Team for the American Cancer Society. There were 412 additional service hours during the month. Meeting attendance for the month was 58%. A motion was made and seconded to approve the previous month's minutes. Report approved.

- 3. <u>Treasurer's Report</u> Candy Hudson provided copies of the report for Board review. The bank balance as of 7/1/09 was \$6,041.24. A motion was made and seconded to approve the previous month's minutes. Report approved.
- 4. <u>Requests for Reimbursements</u> Wayne Ward submitted a bill for supplies (pins, badges, certificates, B.U.G. t-shirt and plaque) ordered from Kiwanis International. A motion was made to reimburse the \$149.62. The motion was seconded and approved.
- 5. <u>Budget Items</u> A motion was made to pay out two budgeted donations \$100.00 to the Tuscola Soccer League and \$100.00 to the Junior Football League. The motion was seconded and approved.
- 6. <u>Children's Miracle Network</u> There is \$100.00 in the budget most of which will be collected from recycling ink cartridges. Action was postponed on this item until month when we will know how much is available from the ink cartridges. To receive a banner patch the donation must be made by September.
- 7. <u>Spastic Paralysis Donation at I-I District Convention</u> \$.50 per members is contributed at each club meeting for Spastic Paralysis Research. There will be about 1,450 contributions made during this fiscal years for \$725.00. The budget amount had been approved for \$900.00. A motion was made that the donation, made at the I-I District Convention, this year would be \$1,000.00. The motion was seconded and approved.
- 8. <u>Club Leadership Training</u> The I-I District will be holding a Club Leadership Training session in Tuscola on July 19th from 1p 5p at Tuscola National Bank. Kevin, Candy and Wayne are registered to attend. Any interested club member can attend to learn about the officer requirements. The cost will be \$5.00 at the door.
- 9. 4th of July Activities All arrangements have been made for our parade entry. Jerry Hall's son-in-law is providing a truck and trailer. The banners and signs were given to Dan Russell for decorating the trailer. Patty Russell will bring costumes. Assistance by the Chamber is still needed for the Kid Zone and beer tent.
- 10.<u>I-I District Convention</u> The convention will be held at the Lincolnshire Marriott Resort, August 6-8, 2009. Online registration deadline is July 22nd. Deadline to certify delegates online is July 15th. If no other members are planning to attend the convention, Wayne will certify David Butler, Janet Butler and himself as official club delegates.
- 11. <u>Request for Donation</u> A letter was received from the Douglas County Senior Service requesting a donation due to State budget cuts. After discussion and the lack of knowledge about the organization, it was decided to invite the Administrator to give a presentation to the club. An envelope could be passed around to members if they wish to make a personal donation.

- 12. <u>Program Presenter Request</u> A letter was received from Steve Alexxis requesting to make a presentation about his products/entertainment services. The Board decided that this did not fit our group.
- 13.<u>BETHS Place</u> The financial situation that may occur if State funding is cut drastically to BETHS Place was discussed. This will be monitored with the possibility of having a special fund raiser for the agency. No decisions were made.
- 14. <u>Traveling Gavel</u> The gavel will be delivered to Sullivan on July 20th at their special meeting being held at Durbin Farm. If no other ideas come up, it will be delivered in a crepe paper ball with candy.
- 15. <u>Tuscola Kiwanis Family Picnic</u> Wayne told the Baord that he and Joann would like to host a Kiwanis family picnic again this summer. Some dates were discussed and it appeared that sometime in August would be the best. Wayne will determine a date and let club members know.
- 16. <u>Pending Public Relations</u> Janet Butler advised that she had two articles, Rail Splitter Wind Farm and the 2010 U.S. Census, prepared to submit to the Tuscola Journal and one article with the Higgins/Jones three generations picture for the Illeiowan. Publicity is very good for the club.
