Dan Craddock introduced via Zoom our speaker, Jason Smith. He has been with IDOT (Illinois Department of Transportation) for 8 years and has been an engineer for 23 years.

Jason is the IDOT Construction Engineer for the Reconstruction I-57/I-74 Interchange Project. This project at \$280 million is four times the cost of any road project ever completed in our district. The current interchange was built in 1963-1965 with tight space and ramps.

The reconstruction provides twelve less tight ramps with higher speeds, large loops, two bridge replacements, rebuilt culverts, noise reduction walls by I-74 residential area, and a widening of the road. The project is scheduled to be completed mid-late 2026, with portions of resurfacing happening in 2027.

ATI primarily offers outpatient physical therapy services which include treatment for a range of musculoskeletal conditions like injuries, chronic pain, post-surgical rehabilitation, sports injuries, and work-related injuries; they also provide specialty therapies like dry needling, taping, and cupping. Usually insurance requires a referral for their services.
